# Participation Authorization and Consent to Emergency Medical Treatment Form

Further, being the parent or legal guardian of the minor child, I do consent to any medical, surgical, x-ray, anesthetic, or dental treatment that may be deemed necessary for my minor child. I understand that efforts will be made to contact me prior to treatment but, in the event I cannot be reached in an emergency, I give permission to the activity leader to make the decisions necessary for treatment. Should there be no activity leader available, I give permission to the attending physician to treat my minor child. As parent or legal guardian, I understand that I am responsible for the health care decisions of my minor child and agree that my insurance plan is the primary plan to pay for the medical, dental, or hospital care or treatment that is given to my minor child. Any insurance policy of the church or organization sponsoring this event will be used as the secondary coverage.

# Warm Beach Camp Ministries dba Black Diamond Camp

## Youth Events - Permission to Participate and Release of Liability

### PLEASE READ THE FOLLOWING CAREFULLY

**Release/Participation:** I am the parent or guardian of the participant. I acknowledge the right to consult with legal counsel before signing this release and waiver of claims. With permission, my child may participate in Black Diamond Camp activities including transportation. These may include field games, playground, court sports, bicycles, scooters, pedal-powered trikes, swimming, BB guns, archery, climbing wall, high ropes course, Challenge Course, and axe throwing. While Black Diamond Camp will provide for adequate and reasonable participant safety, I understand that accidents can sometimes happen.

Black Diamond Camp has put in place preventative measures to reduce the spread of COVID-19; however, Black Diamond Camp and Warm Beach Camp Ministries cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending programs at Black Diamond Camp could increase your child's risk of contracting COVID-19.

While at Black Diamond Camp, I agree to comply with all Black Diamond Camp policies, guidelines, signage, and instructions. Because Black Diamond Camp is open for use by other individuals, I recognize that my child is at higher risk of contracting COVID-19. With full awareness and appreciation of the risks involved, I, on behalf of my child, acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending Black Diamond Camp and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I am not relying upon Black Diamond Camp to list all possible risks. Therefore, I allow my child to participate in camp activities, I understand and expressly acknowledge that I release Black Diamond Camp and Warm Beach Camp Ministries, its employees, board of directors, volunteers, or guests from all liability for any injury, loss or damage connected in any way whatsoever to participation in Black Diamond Camp activities, whether on or off Black Diamond Camp's premises and including transportation. I waive any and all claims, fixed or contingent, known or unknown, arising from participation in activities at Black Diamond Camp. I understand that this release includes any claims based on negligence, action or inaction of Black Diamond Camp, its employees, board of directors, volunteers, or guests whether related to an incident or a COVID-19 infection occurring before, during, or after participation in any Black Diamond Camp program or activity.

**Consent for Medical Treatment:** I give permission for the Black Diamond Camp staff or volunteer nurse to follow the physician's standing orders for care and treatment of me or my child(ren). I give permission to the physician selected by Black Diamond Camp to provide emergency medical treatment for me or my child and to transport them to an emergency center for treatment. I understand that this emergency care may require the physician to hospitalize, secure proper treatment for, and to order injections, anesthesia, or surgery for the campers named on this form. I understand that every effort will be made to notify the parent or guardian of the camper when medical attention is required at a hospital or clinic.

**Insurance:** I understand that Black Diamond Camp/Warm Beach Camp Ministries does not provide any primary accident or health insurance for campers and guests and further understand it is my responsibility to provide such coverage.

**Property Loss:** Black Diamond Camp/Warm Beach Camp Ministries is not responsible for personal property lost, damaged, or stolen while participating in Black Diamond Camp programs or while using Black Diamond Camp facilities, including parking lots.

**Photograph Permission:** I give permission for Black Diamond Camp/Warm Beach Camp Ministries to use, without limitations or obligation, my and my child's likeness as expressed in all digital outputs including, but not limited to, photographs, film footage, artwork, or tape recordings, for the purposes of promoting or interpreting Black Diamond Camp and Warm Beach Camp Ministries and its programs.
